Professional Development

Michelle Shroyer, Health Educator presented an overview on Tobacco Prevention Initiatives.

One initiative included the creation of the Vaping Tobacco Coalition to develop activities to reach low income

populations.

Michelle also shared information on the point of sale efforts including the location of tobacco retailers versus school locations, tobacco prices, and audit checks.

Michelle explained the 2021 ADmagine Truth Contest and shared Tik Tok videos created for the contest.

Board members were asked to pick the winner. The prize was shared between John Glenn High School and Foxfire.

ZMCHD COVID-19 Incident Command



January brought a downward trend in our new COVID-19 cases to 2,038 from 2,855 in December. We saw our triple-digit new cases/day decline to only two of 31 days compared to 13 of 31 for December; while our active cases averaged 654/day compared to 1,096/day in December.

COVID-19 cases continued to decline in February. By the end of the month the total number of new cases went to 95. This

was the first time since September 2020 that our total number of new cases was back to two digits. In addition, the number of active cases per day started the month at nearly 500 and declined to 99 active cases.

COVID-19 cases hit a weekly low at 60 the week ending March 20th. The number of new cases per day fluctuated from a low of 3 to a high of 26. A total of 328 new cases were added during March.

In April, cases continued to decline to a new weekly low of 46 cases the week of April 24th. A total of 265 new cases reported for the month down from 328.

COVID-19 cases continued to decline in May. The weekly low of 21 cases/week May 29th was less than half of the April low week of 46 cases. The number of new cases ranged from 0 to 9, another downward trend compared to the 3 to 26 range in April.

COVID-19 Vaccination



January brought an upward trend in our vaccination numbers to 1,350 from 270 in December. Our vaccination program ramped up to try to meet the State's expectations of administering COVID-19 vaccine beginning within 24 hours of receipt and having each week's allocation distributed within 7 days.

Vaccination numbers continued to increase in February. We completed 19 clinics and gave 2,160 vaccinations. One was canceled due to a vaccine delay and two were delayed by weather. Eight were held at the Muskingum County Fairgrounds.

In March, we gave 3,746 vaccines.

The demand for vaccinations started to decline in April with the decision to pause the use of J&J vaccine for a few weeks. We administered 2,725 doses of vaccine.

Demand continued to decline in May with 530 doses of vaccine given. Our total doses administered December-May reached 10,793.

Abbot At-Home COVID-19 Test Kits



We partnered with the Muskingum County Library System to make Abbot Binax NOW Rapid COVID-19 tests available at all library branches free of charge to community members.

ALL MCLS locations are currently open Monday-

Thursday 10AM-7 PM, Friday 10AM-6 PM, and Saturday 10 AM-4 PM. No appointment is necessary and tests are free to the public.

The test kits are to be used in conjunction with a tele-med app. Access to a smartphone or tablet or a computer with an internet connection is required. The library has free high-speed wifi available in all outdoor spaces. If technology assistance is needed, please email techhelp@muskingumlibrary.org to set up a free virtual technology help session.

Health District Advisory Council Meeting

The annual meeting of the Zanesville-Muskingum County Combined General Health District Advisory Council Health District Advisory Council was held in conjunction with the Muskingum County Township Association Annual Spring Banquet at the Health Department and as a virtual meeting on March 24th.

Approximately 10 members of the group participated from our newly renovated conference room.

We had enough attendees to fulfill the requirement for a quorum and the Council unanimously reappointed Jennifer Agin to the Board of Health for the term April 1, 2021 to March 31, 2027.

Accreditation Update

A 90 day extension was given to all health departments to improve and resubmit accreditation measures due to COVID-19.

We decided to apply for a oneyear extension to ensure we had the proper time to put the improvements necessary into place.
